Notice Regarding Election of Candidates for Directors After Transition to a Company with Nominating Committee, etc.

KADOKAWA CORPORATION (Head office: Chiyoda-ku, Tokyo; President and Member of the Board: Takeshi Natsuno; hereinafter the "Company") hereby adopts a resolution that it elected, at a meeting of the Board of Directors held today, candidates for Directors to be proposed to the 9th Annual General Shareholders Meeting scheduled to be held on June 22, 2023. This is based on the previously announced IR news titled "Future Initiatives in Response to the Recommendations for Improvement from the Corporate Governance Inspection Committee", which was resolved at the meeting of the Board of Directors on February 2, 2023, to the effect that the Company will transition to a Company with Nominating Committee, etc. from the current structure of a company with an Audit & Supervisory Committee, conditional upon the approval of the relevant proposal at the said general shareholders meeting.
