(Headquarters: Minato-ku, Tokyo; President & CEO: Nao Udagawa) have confirmed the release date of “The Forsaken Hollows” downloadable content (DLC) for joint-developed co-op action survival game “ELDEN RING NIGHTREIGN” (published by FromSoftware in Japan and by Bandai Namco Entertainment in overseas territories). The DLC will be released on 4th December, 2025 (Thu).
